GENERAL PROVISIONS

-These Terms are governed by the laws and regulations of the Saudi Insurance Authority (**IA**), and disputes shall be settled by competent courts or insurance dispute resolution committees in Saudi Arabia.



DATA PROTECTION AND BREACH NOTIFICATION

- -FAL Insurance Brokerage is committed to applying the highest technical and organizational standards to protect customer data in accordance with **IA** regulations, the **PDPL**, and **NDMO** guidelines.
- -User data is retained for no less than ten (**10**) years after the end of the contractual relationship or as required by law.
- -In the event of a data breach, the company will notify the Insurance Authority within **72** hours of discovery, as required by applicable regulations.

DATA PROTECTION AND BREACH NOTIFICATION

- -If the breach directly affects a user's personal data, the user will be notified, including the nature of the compromised data and corrective measures taken.
- -No data shall be transferred outside the Kingdom without obtaining prior regulatory approvals from the Insurance Authority and other relevant entities.
- -The user acknowledges that their use of the website involves data sharing under regulatory controls, and the company shall not be held liable for breaches resulting from user negligence or third-party actions beyond its control.
